The baseline for this assessment was the Certification Report, the Security Target and the Evaluation Technical Report of the product certified by the Federal Office for Information Security (BSI) under BSI-DSZ-CC-0893-2014.

The change to the certified product is at the level of implementation and documentation. The change has no effect on assurance. The identification of the maintained product is indicated by an extension of the product name.

Consideration of the nature of the change leads to the conclusion that it is classified as a minor change and that certificate maintenance is the correct path to continuity of assurance.

The resistance to attacks has not been re-assessed in the course of this maintenance process. Therefore, the assurance statement as outlined in the Certification Report BSI-DSZ-CC-0893-2014 dated 14 April 2014 is of relevance and has to be considered when using the product. 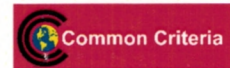
